2023 Stallion Service fee: Private treaty

Stallion Service provided will be *fresh cooled* or *frozen semen*. Stallion Service Fee (SSF) does not include collection cost of \$400.00 per collection (*fee includes overnight shipment within the continental US by either Federal Express or UPS only). Collection fee must be paid to **Creekside Morgans, LLC** prior to shipment. It is the mare owner's responsibility to return Equitainer within seven (7) days. Return shipment expense is the responsibility of the mare owner, there will be a \$50.00 per day late fee on all shipping containers. **Counter to counter** shipments will have a \$75.00 delivery charge added to the standard \$400 shipping fee to cover added airport delivery fees. All same day air shipment cost will be paid by mare owner, cost to be determined at time of shipment. ***Same day semen shipment is available only at mare owners cost.***

Collection of Stallion will be performed at stallion owner's facility of choice. Please contact Tim Murray at least 72 hours prior to anticipated insemination. All required veterinary information and culture results must be **(given)** before requesting shipment of semen.

Mare owner agrees to have designated veterinarian examine said mare within 45 days of anticipated first shipment. At this time, the mare owner must present written results of uterine culture processed by a certified laboratory, along with certification that the mare is free of infection and in good breeding condition to the owner or owner's agent. Shipment will not be provided until this criteria has been met. Veterinarian will examine said mare 30 to 55 days post insemination and mail/email results to stallion owner. These provisions must be repeated for any mare failing to conceive with 2 shipment cycles. Failure to conform to above conditions will nullify all guarantees.

Stallion owner assumes responsibility only to deliver live semen in viable condition at the time of shipment to the mare owner.

Mare Substitution: Should said mare fail to conceive after three (3) cycles, mare owner will have the right to substitute a different owned mare. Substitute mare must be fully identified and results of new exam and culture forwarded to owner or owner's agent before collection can be performed. Approval of substitute mare by stallion owner is required.

Stallion Availability: Services will be available for the 2023 season from March 1 – June 30. Contact Tim Murray regarding any extenuating circumstances should your breeding needs not adhere to this calendar.

Live Foal Guarantee: This service fee includes a live foal guarantee (live foal defined herein as a foal who stands and nurses at birth). Should said are not produce a live foal owner shall be entitled to a return breeding during the same or following season with the same terms. All ensuing collection fees will apply. A statement from a licensed veterinarian as to the details of the foals death within ten (10) days of birth is required or guarantee becomes null and void.

Mare Owner understands that both said mare and resulting foal must be DNA typed by AMHA prior to foal registration. Any foal conceived in any manner not in compliances with the contract or governing registry regulations will not be eligible for registration.

Should the above named stallion become unfit for service before the conditions of this contract are met the contract shall become null and void.
